In August 2009, an internal review and termination U5 was initiated against Michael Bristow based on allegations of, among other things, misappropriation of confidential information. Michael Bristow maintains that the allegations are false and that his U5 should be amended to remove the allegations and disclose voluntary termination from PFS.
